I hope everyone had a great summer of travel. Our summer trip was interesting to say the least. We left Urbanna, VA in mid-July, with a week in Oshkosh Wisconsin at the Experimental Aircraft Association convention, then 82 miles over to Madison Wisconsin to the FMCA International convention, then out to the HWH hydraulic factory in Moscow Iowa.

To give you an idea of the size of the EAA convention, there were over 550,000 people in attendance,

It jammed at the Arcadia rally because the hardwood flooring (which I had installed) got wet and swelled enough to jam the level floor. When the floor jammed, the 5000 psi in the hydraulic system bent a lot of structural slide parts, so that the slide never worked correctly after repairs made in Florida. The experience at HWH was terrific. They did a great job, keeping us up to

date on progress as the work was completed, and big surprise, their bill was less than 1/2 of what I had planned, and they did more work than expected.

We rented a cabin on Lake Rathburn somewhat near by while they worked. When the project lasted more than a week due to the unseen damage, we drove home in the tow car, and I went back two weeks later to retrieve the coach.

Our Spring rally at St. Augustine beach went off

well, and we had 15 coaches in attendance. A highlight was having André Normand as our guest, who met with the guys at our usual "tire kicking" session (See article on pp 5-6). André was president and partner in Prevost until he sold it to Volvo. We enjoyed him and his wife, and they enjoyed taking part in our activities. Other high-

National Director's Report

The National Officer election results are as follows: President: Charlie Adcock incumbent - unopposed; Vice President: Jon Walker incumbent - unopposed; Treasurer: Percey Bell - unopposed; Secretary: Gaye Young elected over John Ferrari.

Membership as of May 31, 2015 stands at 72,754, and the rate of decrease is slowing. Problem is not recruiting new members, it is retaining them, even though the retention rate is a respectable 83%. In the period June 1, 2014 to May 31, 2015, some 10,157 new members recruited, and 13,799 were lost. The Membership Corporation of America has been engaged to work on this problem.

Our Treasurer reports that it is not reasonable to get a fair representation of financial results this year by comparing this year to last, due to some accounting procedures that were changed to provide needed improvements. However, FMCA's financial position is strong, with cash balances of \$546,000

and investment account balances of \$8,987,000.

There were two bylaws revisions approved and six pol-

icy and procedure changes approved. Any member interested in reading these can see them in my records at the upcoming Fall Rally The **FMCAssist program**, which is a medical evacuation program, was reinstated by the Executive Board in Redmond last August as a member benefit. Monthly payments for this comes from earnings (no principal) of the investment account. I attended a meeting on FMCAssist, and I believe it is equal or better than any available outside FMCA. It is administered by Seven Corners Insurance company, phone 1-877-202-4176 in the U.S., and collect worldwide, 1-317-582-2619.

It is of extreme importance that you phone them if you have a claim, or think you might have a claim before any costs are incurred. The company makes all arrangements, and pays all of the bills. They will not reimburse for costs that occur before calling them. To set up a file and begin the claim process, you must phone the Seven Corners company at the appropriate number above, tell them you expect to have or have a claim, and give them your FMCA number. That's the whole procedure and they will

They will return the incapacitated family member or their mortal remains, their family members, pets, and motor home to their home, whether or not they are traveling in a motor home. And they will do this from anywhere in the world, with the exception of the motor home. Worldwide maximum benefits are:

Emergency medical evacuation/repatriation- up to \$500,000;

Emergency medical reunion - Up to \$50,000;

Return of mortal remains- Up to \$50,000; Return of dependents- Up to \$50,000;

Vehicle return (North America only) - Up to \$5,000; Pet return- Up to \$1,000;

Prescription med and glasses replacement- \$500; Assistance service—Included.

There are many more services and exclusions related to this policy that are described in the company brochure. You may phone FMCA for a copy, and I will have some at the SEBN Fall rally.

Just don't make an expensive mistake and lose coverage by not having Seven Corners set up a file.



St. Augustine Rally Report

It's not often that you can camp and enjoy a Bus Nut rally right on an Atlantic beach, so this past April 30-May 2 fifteen coaches pulled in to Bryn Mawr Ocean Resort in historic St Augustine, FL.

Thursday was arrival day for most attendees, and that afternoon, after impromptu gatherings and beverages, most of us carpooled down the coast to a restaurant in Flagler Beach for some excellent seafood.

Friday highlights included beach games, then a fascinating talk by a Florida State Park Ranger, who told us about the importance of the sand dunes and berms, and the annual tribulations of the giant Sea Turtle, whose hatchlings must march from the dune to the surf, at night. Many do not survive.

Friday night we had a lovely steak and chop fry, followed by a lively game of Bingo, called by **Bryan Bowman**.

Saturday we had shuttle tours of old St Augustine, and the narration was very insightful. One of the town's features is Castillo San Marcos, the oldest masonry fort in the US. St Augustine has been under rule by Spain, England, Spain again, then the US.

That night we had a catered pork BBQ dinner with all the 'fixins'. We watched the national telecast of The Kentucky Derby on TV just to get us in the mood, followed by "A Nite at the Races", organized by **Mike Heron**. Each member started with \$400. in 'funny money', and we proceeded to have four simulated thoroughbred horse races up on the big screen. There was excitement in the air during the final race, the "Ed Fisher Handicap", where **Suzanne Bowman** took home the prize for most winnings (all in fun.)

Former Prevost Leader Attends Rally

Paul Normand bought the Prevost Car Company from the family of Eugene Prevost, the founder, in 1957. After a time he brought his son André into the business, and he eventually became president. They took on two silent partners and proceeded to change the manufacturing and purpose of the vaunted Prevost, including making specialty shells available to high-end converters, as well as continuing the famous seated touring coach.

André is a winter habitué of St Augustine, and lives adjacent to SEBN president Ed Fisher, in an RV park right on the beach. Ed and André struck up a neighborly friendship af-

ter realizing they drove both late model Prevosts. Since Ed was hosting the spring rally of the Bus Nuts at his beachside rehe invited sort. André to participate and say a few words at the rally about the company sold it to Volvo

Group in 1995.

One big reason for Prevost dominating the North American tour bus industry in the face of less expensive newcomers like Setra and Van Hool is because those buses do not hold up to rough roads in the northern US and Canada. André acknowledged that they are popular in Europe, but the distance between cities is smaller and those buses do not rack up millions of miles as we do in North America.

One of André's big contributions in managing Prevost was the decision to make shells available to upscale motor home manufacturers. He persuaded his partners that a goal of 24 shells a year was realistic. After a few years, they were

shipping 400 shells annually!

In the beginning they would 'loan' a new shell out to a prospective conversion company, and give them a chance to prove they could make a luxury motor home that would be consistent with the Prevost reputation. It was standard practice for André or an associate to make unannounced visits to each of the several conversion companies to check on quality, etc.

Another of André's major contributions involved the manufacturing process. Since not all coaches were going to be made for tour companies, a standard assembly line like that of MCI was not the optimal build method. Instead each chassis/body was on a large dolly (transporter) and these would go to certain stations while

skipping others. For instance a shell would skip stations where traditional seats, racks, lavatory, a/v, etc. were installed and go right to a paint booth. Also, the seated coach industry required the extremely durable Imron epoxy paint, but the shells were strictly base coat/clear

coat, which gave customers more paint scheme options. So the transporter would take the shell to a different paint booth than the seated coach.

The company has had as many as 22 converters/motor home manufacturers as its customers, but over the years the ones that have converted the most are Marathon, Liberty, and Millenium (formerly Vantaré and Featherlite).

One attraction to the Prevost shell was the fact that the main heating and cooling system lines were already tapped with valves and ready to be adapted to motor home configuration – no cutting into these systems was necessary. Also the Prevost shell floor has the driver and co-pilot on the same level. (Cont'd)

Other appealing reasons for a converter to start with an H series Prevost shell, André said, include the stainless steel chassis and components, the oversize insulated bays, the adoption of the independent front suspension, and the coupling of the electronic DD Series 60 engine with the Allison B-500 World transmission.

André retired from Prevost by Volvo after a

few years working under them. "When you do want you want for 30 years, and you end up with a company that thinks very differently,



and doesn't do everything you want it to do, you cannot stand it. So I retired – relatively young!"

As one of the Southeast Bus Nuts says about his late model Prevost, "It's as roomy and comfortable as a penthouse, and it drives down the road like a Cadillac."

Bulletin Board. After you mix the catalyst it has the consistency of thin mayonnaise. You use a roller and spread it around. It is very sticky, very messy and very expensive. But it truly seals everything it covers. No more leaks!

Two important caveats: pressure wash the roof first to get it super clean, and do the job indoors to keep leaves off, and especially to keep rain off for two days.

Craig and Beverly Bowen are native Ohioans who moved down to Georgia 18 years ago. He was an Eagle Scout who tent camped all his young life. But there was a Bluebird dealer just up the road, and he knew they were built to see the world. He'd wanted one since he was a kid!

He found an older 38 foot 'Bird and completely re-did it, but always had a question in his mind about the venerable DD 8v92 that pushed it down the road. It was tired and it slobbered.

A friend told him about a big MCI DL-3 that member **Ray Cox** had been converting, and he was very attracted to the larger size, the electronic DD Series 60 engine, and all the fundamental mechanical work Ray had done so far. So Craig bought the 1995 coach and proceeded to put in the interior that he and Beverly had always dreamt of. He is especially proud of his four ducted roof airs, which are quiet and effective. They also installed a cross-over aisle to the bedroom, which gives much more privacy than the 'shotgun' layout of the old bus.

Their pattern of bus use is to go out once a month all year. Beverly has driven the bus and knows she can get them off the road if Craig has a health problem. They've been members of SEBN for six years and plan to be at the Brunswick rally. And they hope to make many more rallies in the future!


Longer-term couple

Howard and **Ellen Best**, below, joined the Southeast Bus Nuts in 1990. There are few living members with longer tenure. He was our fourth president, with wife Ellen, his bride of 55 years, as secretary-treasurer.

Howard's career was with United Parcel Service, and he has had decades of experience driving big rigs and managing maintenance for the famous company. He took early retirement to live out a dream—they wanted to full-time in a bus of their own design and configuration. When he bought his venerable MC-8 ("Friendship IV") he used it for a year or two as a charter, then he bore down and undertook the conversion. He turned every screw and tightened every bolt. And when it came to the drive train, suspension, etc., he did all his own work.

Since hitting the road in 1987 they have been to Alaska twice (usually leading a small caravan of intrepid bus conversions) and have been in every state. They've logged 397,000 miles, and bought 66,705 gallons of fuel doing it.

Howard has recently erected a steel building in Kingston, GA that serves as their base. It includes an oversized garage with a pit, and as long as Howard can get over that pit a couple of times a year, he knows that his rig is safe and well maintained. Howard and Ellen rarely miss a club rally, and are often co-hosts or cooks. He has helped scores of members, and has earned the unofficial title. "King of the Bus Nuts"! Truly one of a kind!
